4. RIGHTS OF DATA SUBJECTS

The Data Subject, i.e., you, can exercise your **right of access** in relation to the data that we manage about you, in connection with which, at your request, we will provide you with written information about the data managed by us, the purpose, legal basis and duration of data management, our activities related to data management, as well as who and for what purpose receive or have received your data.

You can request your personal data **be corrected** and, with the exception of mandatory data processing, data **to be deleted and "forgotten".** Furthermore, you can **exercise your right to restrict the scope of data processing** as well as **object to** the processing of your personal data.

With your **right to data portability**, you can request that we release your personal data that you have provided to us so that you can forward this data to another Data Manager.

If we have requested your consent for the processing of your personal data, **you may** withdraw this consent at any stage of the data processing.

If you experience a violation of the law in relation to your data, you have the right **to go to court** and/or **go to authorities**, as well as **claim compensation and damages**.

The interpretation of these rights, as well as stakeholder rights that do not apply to this data management, but are related to our other data management, are contained in Section 4 of the Data Management Principles of GYSEV Zrt.

5. RULES OF PROCEDURE, THAT IS HOW YOU CAN EXERCISE YOUR RIGHTS RELATED TO THE MANAGEMENT OF YOUR PERSONAL DATA:

You can send or submit your comments and requests regarding the handling of your personal data in writing at our contact details provided above or as indicated when recording the data.

We will inform you of the measures taken without undue delay, at the latest within one month of receipt of the request. If necessary, taking into account the complexity of the request and their number, this deadline can be extended by another two months.

If we do not take measures regarding your request without delay, but at the latest within one month from the receipt of the request, we must inform you of the reasons for the failure to take action, the possible extension of the deadline, and the fact that you can file a complaint with a supervisory authority and exercise your right to judicial remedy.

We provide you with the requested information free of charge. If your request is clearly unfounded, repetitive or excessive, taking into account the administrative costs associated with providing the requested information, we may charge a reasonable fee or refuse to take measures according to the request.

In our information provided to you, we may refer to a legal obligation, legal permission, legal restriction or any legal consequence by specifying the paragraph number and the section in question of the referenced legislation and citing the appropriate wording.

We inform all recipients of our correction, deletion or restriction of data processing, to whom we forwarded the personal data; unless this proves impossible or requires a disproportionate amount of effort. At your request, we will also inform you about these recipients.

The information we provide to you shall primarily be issued in electronic format, unless you request otherwise.

6. OTHER INFORMATION REGARDING THE HANDLING OF PERSONAL DATA:

The details on our method used for storing personal data and the security of data management are contained in Section 6 of the Data Management Principles of GYSEV Zrt.

If the data processing is based on your consent, we can process the recorded data without your further separate consent, and also after the withdrawal of your consent, if this is necessary for the purpose of fulfilling a legal obligation or for the purpose of asserting the legitimate interest of a person other than you or us.

Your personal data will only be transferred to a third party if required by law, or if you have given your consent in advance after being properly informed.

We do not use personal data for purposes other than those indicated. Our employees can handle them only to the extent and for the time absolutely necessary to perform their tasks.

In certain cases, the management, storage and transmission of a part of the data provided is made mandatory by law, of which we notify our partners separately.

8. DATA MANAGEMENT OF OUR WEBSITE AND SOCIAL MEDIA APPEARANCES

When visiting the website https://www2.gysev.hu/, the web server automatically logs the activity of the visitor and, if applicable, your activity. The web page is also equipped with google analytics code, so when you visit it, it automatically logs and compiles aggregated statistics on user activity, including your activity where appropriate. Because of the latter, it is not possible to accurately track the user, i.e., you, in Google Analytics.

As a business organization, GYSEV Zrt. also operates a Facebook page and Instagram for the purpose of promoting its activities, providing information about the organization itself and its activities, and conducting marketing activities.

Our company does not connect the data generated during the analysis of the log files with other information, and does not seek to identify the user, i.e., you.

Other data protection information related to the data management of our website, Facebook page and Instagram can be found in Section 8 of the Data Management Principles of GYSEV Zrt.

9. CONTACT - CUSTOMER CORRESPONDENCE

All e-mails received by us with the sender's name, e-mail address, date, time and other personal data provided in the message will be deleted after a maximum of 3 years from the date of communication.

10.1. ELECTRONIC COMMUNICATION WITH PASSENGERS IN INTERNATIONAL TRAFFIC

The purpose of the data management process: When purchasing an international ticket, GYSEV Zrt. provides the opportunity for the customer to provide an e-mail address so that GYSEV Zrt. can electronically send information via e-mail to the person concerned about incidents relating to his/her trip that prevent GYSEV Zrt. from rendering a smooth service, and the consequences of these incidents on the trip.

Scope of data subjects: The natural person whose e-mail address is provided by the person buying the ticket during the purchase of an international ticket at the ticket office of the Data Manager or a third party selling the Data Manager's products (hereinafter: data subject). The person who bought the ticket or the person whose e-mail address is given by the person who bought the ticket can be considered a data subject.

Source of the data processed: The person purchasing a ticket

Brief description of the interest assessment test for the Data Subject: Our company has a clear interest in data processing justified by the legal basis of assertion of legitimate interests as indicated in the above table and in increasing passenger satisfaction. Sending information electronically about incidents affecting international travel is an important economic interest of us. It is also in our legitimate interest to send the data subject information about the management of his/her e-mail address. It is the legitimate interest of the person buying a ticket or traveling internationally to receive adequate information about the events that affect their international travel as well as about the provision of their e-mail address in order to filter out abuses. We have prepared an interest assessment test for such data management, as a result of which it could be established that such data management does not pose great harm to the interests of the Data Subject.
